- USATT rules and regulations will be enforced.

Event: Player may be removed from an event at any time should the Tournament Committee decide that the player is overqualified. The Tournament Committee also reserves the right to cancel any event if there are insufficient entries. Fees will be refunded for any cancelled events.

Equipment: Only USATT approved equipment will be used; 12 STIGA tables and 40mm **Nittaku 3-Star Premium orange** balls will be used. Floors are hard wood floor.
